

SPECIFIC PROCUREMENT NOTICE

SUPPLY OF CONDUCTORS, CABLES AND CABLE ACCESSORIES FOR 66KV LINES

IDA Credit No. 4743-KE, Kenya Electricity Expansion Project

1. This invitation for bids follows the general procurement notice for this project that appeared in the *dgMarket* on 27/04/2010.
2. *The Government of the Republic of Kenya* has received credit from the *International Development Association* towards the cost of the Kenya Electricity Expansion Project. It is intended that part of the proceeds of this credit will be applied to eligible payments under the contract. Bidding will be governed by the World Bank's Eligibility Rules and Procedures.
3. The Kenya Power and Lighting Company Limited now invites sealed bids from eligible bidders for:
KPLC1/6E/2/A12 - Supply of Conductors, Cables and Cable Accessories for 66kV Lines.
4. A complete set of bidding documents in English may be purchased by interested bidders at the address below and upon payment of a non-refundable fee of **KShs.5000** or the equivalent amount in a freely convertible currency. The method of payment will be **Cash** or **Bankers Cheque**, payable at the **Chief Accountant's Office, KPLC, Stima Plaza, 1st Floor**, and receipt obtained.
5. The delivery period is estimated to be about **9 months**.
6. Qualifications requirements include:
 - i. Submission of bid security of **USD75,000** or the equivalent amount in a freely convertible currency.
 - ii. The bidder shall furnish documentary evidence that it has access to credit or liquid asset of upto **US\$150,000**. This may be in the form of a letter from the bidder's bankers or audited accounts for the Last 3 years.
 - iii. The bidder shall furnish documentary evidence that it has supplied similar quantities outside the country of manufacture in the last 7 years.
 - iv. Valid ISO 9001 certificate or equivalent Quality Assurance Certification for the Manufacturer of Goods shall be required.
7. Bidding will be conducted through the international competitive bidding procedures specified in the World Bank's Guidelines: *Procurement under IBRD Loans and IDA Credits* (May 2010 Edition).
