Governor's Office of Business and Economic Development (GO-Biz)



Governor Brown has signed legislation to streamline the state's export certificate program and decrease delays for California businesses looking to export goods.

The legislation allows California businesses requesting an export document from the Department of Public Health to make requests electronically and increases the validity of the document from six months to one year.

The legislation is meant to decrease delays for California businesses looking to enter markets which require a Certificate of Free Sale as part of their required export documentation paperwork. This is an important development that we'll be watching in the near future.
